

## Why Truth Matters in Our Laws

Today you will learn that there is objectively verifiable truth based upon indisputable fact. You will also learn that the Canadian legal system has departed from the truth and has replaced truth with legal fiction.

I am here today to advocate for the truth and to urge you to take on as your mission the restoration of truth to our laws.

It wasn't that long ago that Adolf Hitler and his German government passed laws declaring that Jews were not human beings worthy of living. The German public was brainwashed into believing that Jews were subhuman and inferior human beings that was the cause of suffering by the master class of human beings of Germanic ancestry. Jews were legally murdered by German soldiers following orders.

After World War II, the Nuremberg trials presided over by judges from the winning side, demonstrated that truth rooted in natural law triumphs over positive laws passed by legislatures and political leaders. A defense based upon differential obedience to human made laws in the positive law system of Nazi Germany was rejected as a defense to violations of natural law and human dignity that resulted in harm to vulnerable people who could not defend themselves. Those found guilty of war crimes and crimes against humanity included doctors, lawyers, judges, soldiers and politicians.

We are gathered here today because speaking truth to power is becoming a revolutionary act. It results in prosecutions, imprisonment, deprivation of personal property, blacklisting and silencing by a criminal justice system and human rights laws that eliminate truth as a defense. Once truth and freedom of expression are suppressed, the government and its friendly media collaborators will control the minds of the people. It is foreseeable that soon thought crimes will be enacted and prosecuted, to stop the risk of dissent and opposition.

What is the truth? It is a verifiable or indisputable fact. For example, science objectively proves that a new human being is created at the time of conception. That same person has DNA that establishes the sex of that unborn human being. Yet we are governed by laws that replace truth with fiction. The criminal law says that a factual human being is not a legal person or a human being until that human being is born alive. Human rights laws compel public recognition of self-identification as a member of the opposite sex, or no sex at all. When truth is not permitted as a defense to these laws, this is evidence that our legal system has purged truth from its former role as a foundational element of an authentic justice system.

The oppression of truth and the legal defense of fiction is evidence that legislation passed by Members of Parliament and ideas proclaimed into law by the Prime Minister in his executive power capacity have lost touch with reality and violate the principles of fundamental justice and the Constitution of Canada. This regime of rule by positive law violates the authentic rule of law, by substituting blind adherence to rules that are derived from political ambition and aspirations that do not recognize truth and justice.

The government ignores the Supremacy of God and what the Rule of Law means, which are the two legal foundations of the Charter of Rights and Freedoms. For a law to be just, it must be moral and rooted in truth. It must reflect natural law, values that are for our common good and instinctively known to all people. These legal foundations are embedded in the unwritten constitution of Canada, which must be read together with Constitution Acts of 1982 and 1867.

An example of natural law is that we intuitively know that the killing of an innocent human being is wrong. Restoring natural law and values of freedom, equality, and truth, which are deprived from our nation's Christian heritage is the only way to ensure truth and justice will be restored. The government's hostility to God and Christian values and its adaptation of an intolerant woke secular culture is a wide path to inevitable destruction.

The current federal government relies upon its colonial era power of "peace order and good government," that was intended to preserve law and order and to prevent opposition that is perceived to be not loyal to the Crown. This vestige from the past needs to be abolished, because it is incompatible with a free and democratic society. We desire instead a unifying doctrine that limits the power of government to prevent tyranny in a time of crisis, recognizing that we have God given inalienable rights to life, speech, expression, religion, equality, liberty, property, and security of our person from all government intrusion. This is consistent with the rule of law.

Each one of us possess inherent dignity that is the root of our inalienable rights. Together, we are brothers and sisters who, as equal citizens, are united as one family. Robbing any one of us of our personal unique dignity violates all of us. Foundational to our heritage, is the universal law, to do unto others as you would have done to you. This is the standard upon which our laws must rest, so that justice will be established in this land.

Where there is justice, will flourish a culture of human dignity that enables the blossoming of our society. Take notice that a regime that implements security without the freedoms of thought, reason, faith, conscience and liberty inevitably results in tyranny.

Law must mirror the truth, or the justice system will fall into disrepute for lack of moral integrity and coerced injustice. An unjust law is no law at all.

Let us review the indisputable facts facing Canada today.

The *Emergencies Act* was unlawfully invoked, as the preconditions required by law to invoke the legislation did not exist. What followed was the unprecedented brutality of financial warfare by the freezing of financial assets and the wrongful taking of donated funds away from those who needed the money for survival. Peaceful truckers and their families faced the possible apprehension of their children and the forfeiture of their trucks. They were falsely accused as domestic terrorists in order to sway public opinion. At all times, the government ignores the truth that peaceful protests were legal and the space in front of the Parliament is a national public forum.

What happened in Ottawa could have all been averted by a caring government that could have met with the protesters or their leaders, and engaged in frank and candid discussions to clear up misconceptions and exchange valuable information. Instead the government refused to meet with

their critics, and refused to listen. The fact is that the government detests people who disagree with their policies, and will only meet protesters from organizations they agree with and approve, like Black Lives Matter.

The unpleasant truth is that the government policies and laws regarding Covid violate the Constitution in many ways that are unreasonable in a free and democratic society. Segregation and the creation of a discriminated class of citizens is now government policy, based upon apparent ignorance of the truth of the Covid disease, which is coupled with an agenda to control people.

Science confirms that the vaccines approved for emergency use against Covid do not immunize nor prevent transmission. At best, they reduce severity of symptoms and reduce strain on the health care system. The vaccines are experimental and come with a risk. Informed consent is not provided. People must be given a choice and not be forced by government decree or mandates to take a vaccine or lose their employment, right to travel, or right to fully participate in society.

Despite aggressive censorship, the news of dangerous side effects, including sudden death, disease and injury is becoming public -- data that Pfizer tried to suppress. There is more risk to human health from the vaccines than from the disease itself, for most people under the age of 65.

We are paying the price for government incompetence and totalitarian measures. We have been isolated, lost our freedom, been segregated, suffered discrimination and treated as second class citizens. Our mental health is affected by lockdowns. Our vulnerable drug dependent youth are being fatally poisoned by fentanyl.

We face a new challenge of runaway inflation that is far above the official rate disclosed by the government. The government created inflation by reckless printing of money to pay for a budget that was unaffordable. For most of us, food, gas, and housing prices are now unaffordable. Add to this a penalty carbon tax that further crushes our ability to survive. Political activism is energized when people become desperate.

Do you want political change?

Does truth matter to you?

Will you speak the truth?

Our personal freedoms are in jeopardy. We are under surveillance and subject to cancellation as enemies of the state for political opposition of the current federal government. Those who speak the truth are being eliminated from social media and the government is trying to control content on the Internet.

Our legal goals are simple. Let us restore the supremacy of God, the authentic rule of law and our personal freedoms that are foundational to our Constitution. We are here to defend our Constitution from all those who would rip it up and substitute a distorted culture of hate against our Christian heritage and take away our freedoms.

You ask, "How do I defend our Constitution?" "Is there hope for the future?" "What path do I take to find a solution?"

You will fail before you even begin if you choose to merely defer to the decisions made by those in positions of power and authority.

If you do, you will fail in your duty as a citizen, for you will abdicate your responsibility in a free and democratic society.

Instead you must do the following:

- 1 Question. Investigate. Research. Challenge. Publish. Proclaim. Participate.
- 2 Get politically active. Join a party. Form a party. Your vote is precious. Treasure it. Use it. Be a responsible citizen. If there is no candidate you want to vote for, be that candidate.
- 3 Utilize the courts.
- 4 Educate your children with your values.
- 5 Utilize social media that is not censored.
- 6 Advocate for proportional representation.
- 7 Advocate to abolish tax dollars given to reward people who get elected. It helps keep political parties you don't support in power.
- 8 Expose government corruption.
- 9 Advocate for truth, justice, and moral integrity. Once in power, ensure legislative reform so that all laws conform to truth, justice and moral integrity.
- 10 Don't be afraid of what others may think or say. Think for yourself. Publicly and privately debate the issues. Voice your disagreement. Explain your position. Listen to opposing views. Learn from one another.
- 11 Engage every person and authority who seeks to silence the truth. Be bold and courageous.
- 12 Be willing to pay the price to restore the rule of law and the supremacy of God. Truth is not cheap. There is a heavy cost. You may end up sacrificing everything you have and cherish.

There is hope for the future if you step up as responsible citizens.

Will you be responsible citizens?

Democracy dies without active participation. Democracy dies when you do nothing.

Will you keep democracy alive?

I salute you for being here, to carry the torch of truth, to be a light to the world.

We are the voice that will not be silenced. Together we are one. We are witnesses to the truth. The truth shall set us free.
